SECTION 4 – FIRST AID MEASURES

4.1 Description of first aid measures

Inhalation: If product dust or vapor causes respiratory irritation or distress, move the exposed person to fresh air immediately. If breathing is difficult or irregular, administer oxygen; if respiratory arrest occurs, start artificial respiration by trained personnel. If unconscious, maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. If irritation persists or if the victim feels unwell, seek medical attention.

Eyes: Immediately flush eyes with large amounts of water or saline solution for at least 20 minutes, occasionally lifting the upper and lower lids. Remove contact lenses if present and easy to do after first 2 minutes and continue rinsing. Seek immediate medical attention, preferably from an ophthalmologist.

Skin: Flush skin with large amounts of water while removing contaminated clothing. Wash the affected area with soap and water followed by thorough rinsing. Wash contaminated clothing and shoes before reuse. If irritation persists, seek medical attention.

Ingestion: Rinse mouth with water if the victim is conscious. Remove dentures if present. DO NOT induce vomiting unless directed to do so by medical personnel. Give 1 - 2 cups of water to drink if the victim is conscious, alert, able to swallow and not experiencing respiratory distress. Vomiting may occur spontaneously. To prevent aspiration of material into the lungs, lay the victim on one side with the head lower than the waist. Never give anything by mouth to an unconscious or convulsing person. Do not leave the victim unattended. Seek immediate medical attention.

4.2 Most important symptoms and effects, both acute and delayed Potential health symptoms and effects

Eyes: Causes severe eye irritation and serious eye damage. Symptoms may include inflammation, swelling, pain, tearing, burns and blurred vision. Particulates can cause mechanical irritation of the eye and surrounding tissues.

Skin: Causes skin irritation with redness, itching and discomfort. Prolonged and repeated contact with unprotected skin may cause dermatitis. May cause an allergic skin reaction and subsequent sensitization in some individuals.

Inhalation: May cause respiratory irritation with headache, sore throat, cough and shortness of breath. May cause asthma-like symptoms in sensitive individuals.

Ingestion: Harmful if swallowed. Symptoms may include nausea, vomiting, pain and diarrhea. May damage the gastrointestinal system and the liver. May damage the immune system. This material may get into the lungs during swallowing or vomiting causing lung inflammation and chemical pneumonitis, which may be fatal. Symptoms of aspiration into the lungs include coughing, gasping, choking, shortness of breath, bluish colored skin, rapid breathing and rapid heart rate.

Chronic: Pre-existing disorders of the skin and respiratory system may be aggravated by exposure to this product. Chronic exposure may cause damage to the gastrointestinal system and liver. May cause damage to the immune system. Chronic inhalation may result in asthma-like symptoms. May cause an allergic skin reaction with subsequent sensitization to similar amines. Chronic exposure to unprotected skin may cause dermatitis.


