## **SECTION 4 - FIRST AID MEASURES**

#### 4.1 Description of first aid measures

**Inhalation:** If product mist or vapor causes respiratory irritation or distress, move the exposed person to fresh air immediately. If breathing is difficult or irregular, administer oxygen; if respiratory arrest occurs, start artificial respiration by trained personnel. If unconscious, maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. Seek immediate medical attention.

**Eyes:** Immediately flush eyes with large amounts of water or saline solution for at least 15 minutes, occasionally lifting the upper and lower lids. Remove contact lenses, if present and easy to do, after first 2 minutes and continue rinsing. Seek immediate medical attention, preferably from an ophthalmologist.

**Skin:** Rinse skin with water while removing contaminated clothing. Wash the affected area with soap and water followed by thorough rinsing. Wash contaminated clothing and shoes before reuse. If irritation persists, seek immediate medical attention.

**Ingestion:** Rinse mouth with water if the victim is conscious. Remove dentures if present. Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, the head should be kept lower than the waist so that vomit does not enter the lungs. Never give anything by mouth to an unconscious or convulsing person. Do not leave the victim unattended. If the victim is unconscious, place in the recovery position and get immediate medical attention. Immediately contact a poison control center or doctor. Seek medical attention if the victim feels unwell or if a large quantity of material has been ingested.

## 4.2 Most important symptoms and effects, both acute and delayed

#### Potential health symptoms and effects

**Eyes**: Causes severe eye irritation. Symptoms may include redness, swelling, pain, tearing and blurred vision. Vapor or mist can cause eye irritation. Symptoms may be delayed.

**Skin:** Causes skin irritation with redness, itching, discomfort. May cause skin discoloration (yellow). May cause skin sensitization, an allergic reaction, which becomes evident upon re-exposure to this material. Glyoxal is considered to be a strong human sensitizer. May be harmful if absorbed through the skin.

**Inhalation:** Harmful if inhaled. Inhalation of mist, aerosol or vapor may cause irritation of the respiratory tract. Irritating to the mucous membranes in the nose, mouth and throat. May cause headache, cough and shortness of breath and nausea.

Ingestion: Harmful if swallowed. Causes irritation of the gastrointestinal tract with nausea, vomiting, abdominal pain and diarrhea.

**Chronic**: Persons with preexisting skin disorders and respiratory impairment may be more susceptible to the effects of this substance. May cause skin sensitization. Exposure to high concentrations may cause depression of the central nervous system with possible risk of irreversible effects. May cause damage to the kidneys

## 4.3 Indication of any immediate medical attention and special treatment needed

## 5.1 Extinguishing media

#### SECTION 6 – ACCIDENTAL RELEASE MEASURES

#### 6.1 Personal precautions, protective equipment and emergency procedures

Evacuate non-essential personnel. Wear appropriate protective clothing and equipment designated in Section 8.2. Ventilate the area. Remove all sources of ignition. No smoking. Clean up spills immediately. Spill creates a slip hazard.

#### 8.2 Exposure controls

**Engineering measures:** Technical measures and appropriate working operations should be given priority over the use of personal protective equipment. Use adequate ventilation. Local exhaust is preferable. Refer to Section 7.1.

#### 11.2 Further information

There is insufficient data to classify glyoxal as a human or animal carcinogen. Glyoxal was found to promote stomach carcinoma in animals in one study and to be a direct-acting mutagen in bacterial and mammalian cell assays in extensive testing. NIOSH has noted the similarity of its mutagenic profile to formaldehyde, acetaldehyde, and malonaldehyde and has advised concern regarding its carcinogenicity. Squamous cell metaplasia was observed in the rat larynx after 29 days of exposure (6 hours/day, 5 days/week) to 2 and 10 mg/m3 of a 40% glyoxal aerosol. In a human maximization test for contact allergens, glyoxal rated 5 on a scale of 1 to 5. Glyoxal is considered to be a strong human contact sensitizer.

This product contains no substances present at levels greater than or equal to the 0.1% threshold (de minimis) that are identified as probable, possible, potential or confirmed carcinogens by ACGIH, IARC, NTP or OSHA. No data is available regarding the mutagenicity or teratogenicity of this product, nor is there any available data that indicates it causes adverse developmental or fertility effects.


