SECTION 4 – FIRST AID MEASURES

4.1 Description of first aid measures

Inhalation: If product mist or vapor causes respiratory irritation or distress, move the exposed person to fresh air immediately. If breathing is difficult or irregular, administer oxygen; if respiratory arrest occurs, start artificial respiration by trained personnel. If unconscious, maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. Seek immediate medical attention.

Eyes: Immediately flush eyes with large amounts of water or saline solution for at least 15 minutes, occasionally lifting the upper and lower lids. Remove contact lenses if present and easy to do after first 2 minutes and continue rinsing. Seek immediate medical attention, preferably from an ophthalmologist.

Skin: Rinse skin with water while removing contaminated clothing. Wash the affected area with soap and water followed by thorough rinsing. Wash contaminated clothing and shoes before reuse. If irritation persists, seek immediate medical attention.

Ingestion: Rinse mouth with water if the victim is conscious. Remove dentures if present. Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, the head should be kept lower than the waist so that vomit does not enter the lungs. Never give anything by mouth to an unconscious or convulsing person. 4.2 Most important symptoms and effects, both acute and delayed

Potential health symptoms and effects

Eyes: May cause mild eye irritation with redness and discomfort. Prolonged eye contact may cause slight corneal injury.

Inhalation: At room temperature, exposure to product vapor is minimal due to its low volatility. Inhalation of mist or vapor may cause irritation of the upper respiratory tract. Symptoms may include headache, cough and difficulty breathing.

SECTION 5 – FIRE FIGHTING MEASURES

5.1 Extinguishing media

Suitable methods of extinction: Use extinguishing media such as dry chemical, carbon dioxide, alcohol-resistant foam, water spray or water fog. Unsuitable methods of extinction: Water jets or streams can spread the fire.

5.2 Special hazards arising from the substance or mixture

Combustible liquid at high temperatures. Closed containers may rupture due to the buildup of pressure when exposed to extreme heat. 5.3 Advice to firefighters

SECTION 6 - ACCIDENTAL RELEASE MEASURES

6.1 Personal precautions, protective equipment and emergency procedures

8.1 Control parameters
